

HEERF - Student Financial Aid Report

1st Quarter Report

April 10, 2023

(1) On May 6, 2020, Emerald Coast Technical College signed and returned to the Department the Certification and Agreement and the assurance that the institution has used, or intends to use, no less than 50 percent of the funds received under Section 18004 (a)(1) of the CARES Act to provide Emergency Financial Aid Grants to students.

(2) The total amount of funds that the institution will receive or has received from the Department pursuant to the institution's Certification and Agreement for Emergency Financial Aid Grants to students under Section 18004 (a)(1) of the CARES Act to provide Emergency Financial Aid Grants to students is \$729,655.00

(3) The total amount of Emergency Financial Aid Grants distributed to students under Section 18004 (a)(1) of the CARES Act to provide Emergency Financial Aid Grants to students as of April 10, 2023 is \$729,655.00

(4) The estimated total number of students at the institution that are eligible to receive Emergency Financial Aid Grants to Students under Section 18004 (a)(1) of the CARES Act to provide Emergency Financial Aid Grants to students as of April 10, 2023 is 73.

(5) The total number of students who have received an Emergency Financial Aid Grant to students under Section 18004 (a)(1) of the CARES Act to provide Emergency Financial Aid Grants to students is 346. 121 students received \$152,555.00 on May 29, 2020, 13 students received \$32,500.00 on March 25, 2021 15 students received \$37,500.00 on June 8, 2021, 45 students received \$92,750.00 on September 16, 2021, and 1 student received \$2,500.00 on December 9, 2021, 65 students received \$219,500.00 on February 24, 2022, 86 received \$97,050.00 on October 10, 2022, and 73 received \$95,300.00 on March 6, 2023.

(6) The following method and considerations were used by the institution to determine which students receive Emergency Financial Aid Grants under Section 18004 (a)(1) of the CARES Act to provide Emergency Financial Aid Grants to students: data derived from attendance, current enrollment, enrollment hours, student financial aid qualifying totals, other scholarships and student waivers of those students enrolled at the time of the CARES Act disbursement were considered in Emerald Coast Technical College's (ECTC's) individual student allocations. Only student applicants who were affected by the disruption of campus due to the coronavirus, such as food, housing, course materials, technology, health care, and child-care expense received emergency financial aid. With these considerations, a disbursement of \$1,225.00 was established for dual enrolled students, \$1,315.00 for adult students and \$800.00 for an adult education student. Two dual enrolled students received \$1,225.00 each for a total of \$2,450.00, seventy adult students received \$1,315.00 each for a total of \$92,050.00, and one adult education student received \$800.00. A total of 73 students received a total award of \$95,300.00 on March 6, 2023.

(7) Students were notified of the availability of Emergency Financial Aid Grants and provided instructions for assessing those funds through Remind, sign announcements, teacher emails, and student email blasts. The application for the March 6, 2023 disbursement opened on February 6, 2023 and closed on February 16, 2023. Checks were available to students on March 6, 2023.
